Attached is the proposed revision of the Floodplain Standard provisions (Article 12) of the Town's land use ordinance, which we hope to present to voters at Town Meeting this May. The text is unchanged from what was presented at a public hearing Monday evening.

The proposal is a "strike and replace" approach to the article using model language provided us by DACF. Would you please review the language its technical and legal sufficiency?
